### **General Fund**

We were able to help more than a dozen charities last year and we hope to do the same in 2010. Below you find the list of charities being supported by our sectors this year, together with the Chaplaincy-wide charity, **Emmaus**.

'Unspecified' monies continue to be collected for the general fund of CHAP-AID. This means we are able to respond immediately to dire emergencies, as we saw earlier this year with Haiti, without first having to come to you, our contributors, for funds. We need to remember the need for funds on standby for emergencies, if we do wish to respond in this way. Sadly, there is all too often some catastrophic need for this fund.

### **Chaplaincy-wide Charity for Aquitaine for 2010**

In December 2009 we completed our three-year contract with "Churches in Partnership with World Vision – the Stepanavan project."

As agreed at our AGM in April, for 2010 our main charity for the whole Chaplaincy will be Emmaus. We also agreed at the last AGM to support the Bishop's Advent and Lent Appeals.
